We launched a committee, co-chaired by Walt Barber and Vic Kimm, that will explore how we can describe the important improvements in the environment which EPA and its State, Tribal, and Territorial partners have accomplished in nearly a half century. A complimentary effort, led by Dave Calkins, Phyllis Flaherty and Fran Phillips will be working on identifying subject matter experts who could serve as mentors for EPA employees, speak to local groups on environmental issues, and be resources for the project being developed by the committee being led by Vic and Walt. We have also decided that the oral histories we have and will develop should be made available to the public, and a special

Carol Browner Addresses DC Get Together

Carol Browner, EPA's 8th administrator, spoke to the annual meeting of the EPA Alumni Association on May 7th in Washington. Over 100 members attended in person, as did a number from outside Washington who were able to call in to participate. Those in Washington were joined by President Dave Calkins and Board member Stan Legro who flew in from California for the meeting and Vice-President Fran Phillips who flew in from Dallas.

Browner took some time to cite what she considered the high points of her tenure at EPA: creation of the Superfund Brownfields program; increased focus on children and the environment; and the regulation of fine particles under the Clean Air Act.

The low-point, she said, was when the House of Representatives began working to implement the "Contract With America." The subsequent government shut-down created an atmosphere of disdain for government and for public service.

What started as a dark period, she said, became the opportunity for her and agency employees to tell the EPA story---the value of strong, fair regulation; and why you "need a cop on the beat." It was, she said, a chance to build necessary credibility and public support for EPA. *Click here to continue.*



# Anti-EPA Ads & Web Site What Next, Flying Monkeys?

Full page ads have been placed in USA Today attacking EPA and inviting readers to visit the web page of the sponsoring "Environmental Policy Alliance." The first ad appeared May 15 and keyed off the IG investigations of management issues at EPA. It called the Agency "a Joke." On June 3 another ad ran -- the day after EPA's proposed CO2 regulation was released. That ad read: "What would you call a radical organization that threatens to shut down 25 percent of our electric grid?" Three potential answers - anarchist, militia, and terrorist - are all struck out, leaving "Obama's EPA" as the only answer.

There is no list of members, officers, or funders of the Alliance on its web site. The physical address for the Alliance is the same as the address for Berman and Company, whose web site describes it as "a dynamic research, communications, advertising, and government affairs firm. Berman and Company isn't your average PR firm. Our mission is to 'change the debate,' not simply contribute to it." The CEO of the PR firm is Richard "Rick" Berman.

The Environmental Policy Alliance may have something in common with the Wizard of Oz - a booming voice emanating from a small person hiding behind a curtain. There could be a trade association, a company or companies, or a single individual hiding behind the "Alliance" curtain. Perhaps the ads were purchased by a person or company whose customers, clients or friends might take a dim view of attacks on the Environmental Protection Agency or its mission. Interestingly, the Alliance takes EPA to task for a "lack of transparency" in policy formulation. Right.



#### RTP Retirees Donate 58 Acre Farm

Bob Kellam and his wife, Susan Wyatt, both long-time career employees in the Office of Air Quality Programs and Standards at RTP, retired from EPA in 2004. But that turned out not to be the end of their concern about the environment.

Kellam had grown up in the Raleigh area, spending much of his childhood on the farm originally owned by his grandfather. Once some 400 acres, and considered "out of town" when Kellam was young, the farm now comprises almost 60 acres and is surrounded by shopping centers and housing developments and is part of the City of Raleigh.

Kellam and Wyatt now own the farm where they have lived since 1970; they built their house on a hill overlooking a favorite view from Kellam's boyhood treehouse. They have not taken an easy path into retirement, rather they have devoted their time and energy to environmental education, open spaces and local and sustainable farming. He started a local CSA (Community Supported Agriculture) cooperative and became a certified Master Gardener. He and his wife raise some 40 different crops on a small part of their farm that they sell at the Midtown Farmers' Market.
