Lee Thomas Remembers

Recently I had the chance to talk with Lee Thomas about his six-year tenure at the Agency. Lee served as Administrator from February 1985 to January 1989 at a critical time for the Agency. Before taking the helm, Lee was Assistant Administrator for Solid Waste and Emergency Response, and had been with FEMA before that. When he left EPA Lee became CEO of an engineering firm, then joined Georgia Pacific, managing its environmental and engineering programs before becoming President and COO. He joined the Board of Rayonier Corporation, a forest products company, and has been its CEO since March 2007. Bob Wayland, Editor

Lee, would you tell our members about your arrival at EPA?

The White House called me one afternoon soon after Rita Lavelle departed EPA, and asked me to go to the Agency as Acting Assistant Administrator for Solid Waste and Emergency Response. EPA had been on the front page of the papers for weeks and, as Associate Director and Acting Deputy of FEMA, I had met Anne Burford while chairing the Times Beach Task Force. I arrived at the agency a few days after the phone call. I went to the Administrator's Office and was told that she wasn't expected in until after 10. I found my way to the AA's Office, above the Safeway, and introduced myself to the Office Directors, John Skinner, Bill Hedeman, and Gene Lucero. My briefings began immediately and I remember Gene warned me that at EPA I would have to make a lot of decisions and most of them would make many people unhappy.

Later, I met the Administrator who seemed somewhat surprised to see me. She told me that she didn't need any help and suggested I return to FEMA. I said I'd be happy to if the White House would call me and tell me that's what they wanted. Obviously, that didn't happen and less than a month later the White House announced Anne Burford's resignation. Lee Verstandig had been detailed to EPA at the same time I was as the Acting Assistant Administrator for Public Affairs. When Anne Burford left, Lee became Acting Administrator and I became Acting Deputy Administrator in addition to my OSWER role. He told me he had longstanding vacation plans for the following week, so I would be Acting Administrator. So, a month after I reported to EPA I was Acting Administrator, Acting Deputy Administrator, Acting AA for OSWER as well as Acting FEMA Deputy and FEMA Associate Director. Jack McGraw, who fortunately I had managed to recruit from FEMA as my deputy in OSWER, commented that it was one of those rare times when I could send a memo from me, through me, to me!

I was impressed with the ability and dedication of the EPA staff and that impression was only strengthened in my six years at EPA. I was very fortunate, along with the rest of the Agency, when Bill Ruckelshaus returned as Administrator. He assembled an excellent team, with Al Alm as Deputy, Jim Barnes as General Counsel, Milton Russell as AA for Policy, Jack Moore as AA for Pesticides and Toxics, Bernie Goldstein as AA for ORD, and Howard Messner as AA for Administration.
