Dear Friends and Colleagues,

This is the Association's first hardcopy newsletter! We have distributed 14 newsletters by email (back copies are available at www.EPAalumni.org). Our production and distribution costs using email are very low, suited to an organization with no dues or joining fees. But we are all inundated with email and a significant number of members don't open e-newsletters or their computers block messages from ConstantContact, our delivery service. So we decided to do something different for this issue.

If you haven't checked out our web site recently, we think you will be pleased with changes to make the site more topical and user friendly. Any member may post photos, news, recollections of their EPA colleagues and adventures. We encourage you to do this. After recording a growing collection of oral histories, which we are making available to the public, we want to expand to other representations of the Agency's history – memorabilia, songs, etc.

Our ranks continue to grow, but new members have not been joining at the rates we saw a couple of years ago. We have also donated small amounts from the treasury for such events as the reception at the Air and Waste Management Association in Raleigh which Gina McCarthy attended.

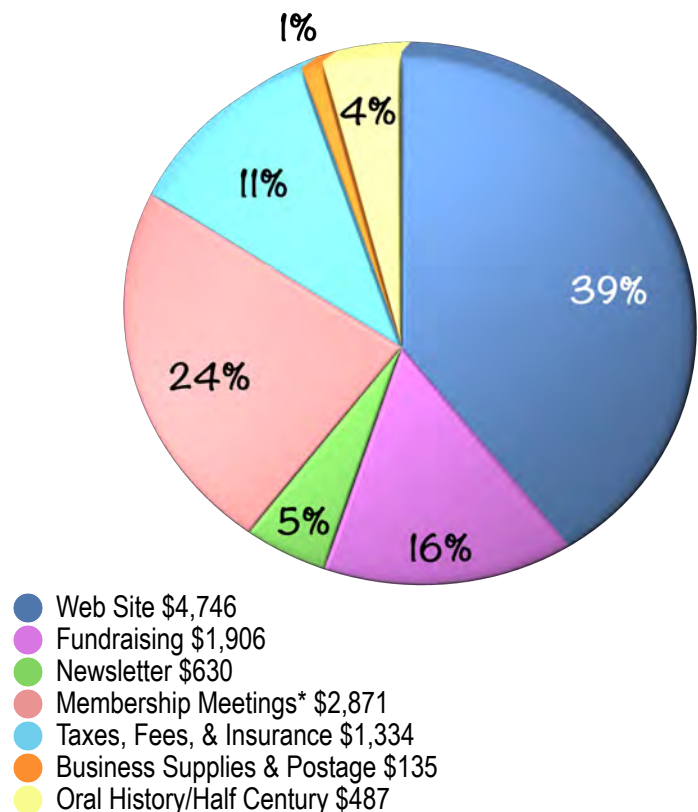

Our unpaid Executive Director, Board Members, Committee Members and other volunteers do essentially all the work of running the Association and producing its products. Our recent expenses have run about \$12,000/year. This is equivalent to about \$10 per member annually. The generous voluntary donations of Members and friends and in-kind contributions of services have allowed us to continue our practice of charging no dues or fees. More than a third have donated at least once and many have contributed annually. We are anticipating the need for video editing and e-book development services that we cannot perform in-house for the next phases of our history and Half Century of Progress projects.
