We will use this hiatus to further improve teaching materials we have developed. A few dozen Association Members had volunteered to conduct teach-ins. I hope many more volunteers will step forward to help tell the story of conditions that led to EPA being established, the programs we implemented to address environmental problems, successes, remaining problems, and more recently identified threats to health and the environment. We are just a few days from completing the updates to our **Half Century of Progress** Reports which are being formatted into attention grabbing formats. I am grateful to the many Association Members who have worked on these Reports which highlight additional work that must be done to maintain progress and tackle new issues like the Climate Crisis. The content of these Reports provides much of the material for our Teach-in presentations. The updated Reports will begin to appear online soon.
