

EPA Alumni Academy - Earth Day Message

As we celebrate the 51st anniversary of Earth Day, the EPA Alumni Association is geared up to provide more and more content filled programs by alums for alums and other experts! The whole idea is to tap into the many years of experience and insights into environmental and public health protection of our alums and share that with others so we can live up to our motto "We're not done yet!"

We hit the ground running in December 2020 with a joint program with the Environmental Protection Network that focused on their report called "Resetting the Course for EPA." In January 2021, we gave an update of the program we did in April 2019 with American University entitled "What's Next for EPA." We followed that with "Renewal of EPA's Public Health Protection" in February 2021 and then "The Tale of Two Rivers: The Potomac and the Rio Grande." The Academy Committee is in the process of considering programs on rebooting science at EPA, environmental justice, climate change, environmental and public health relations among federal, state, tribal, and local governments, and much more.
